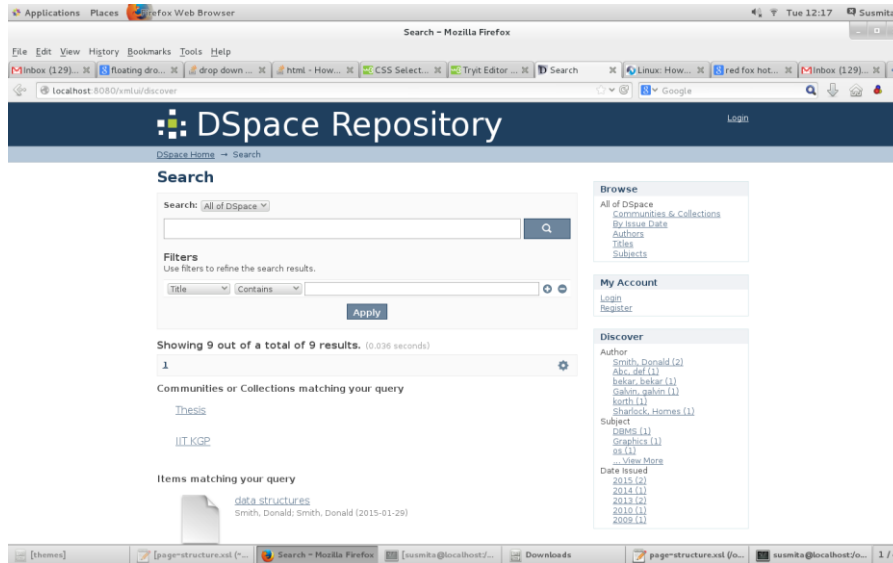

1. Introduction

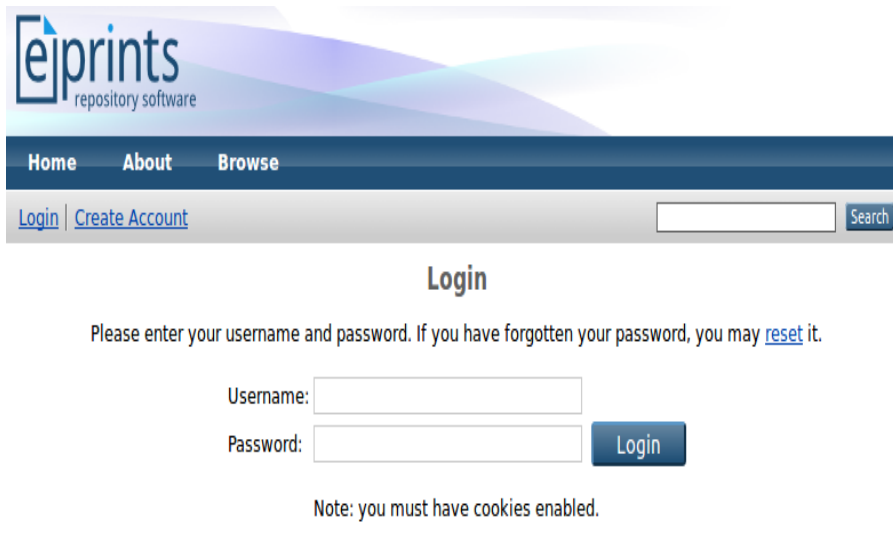

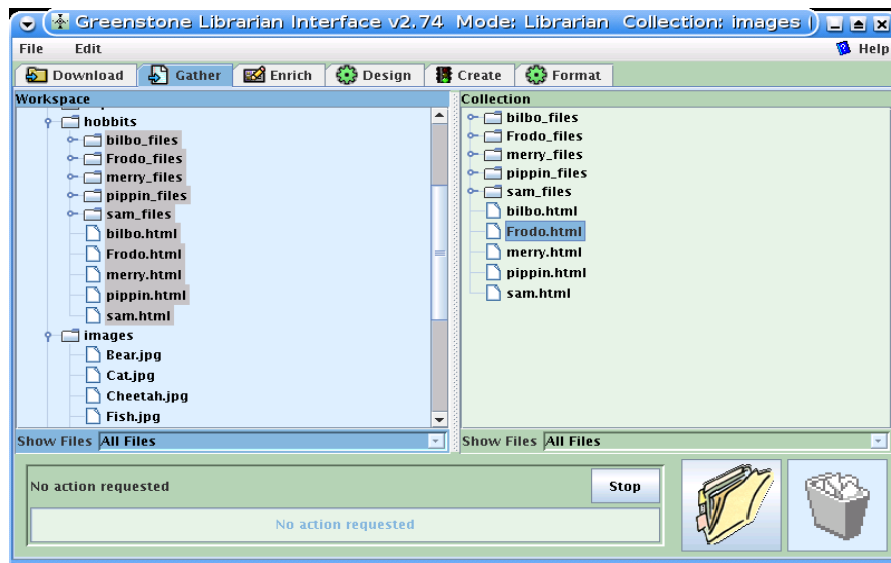

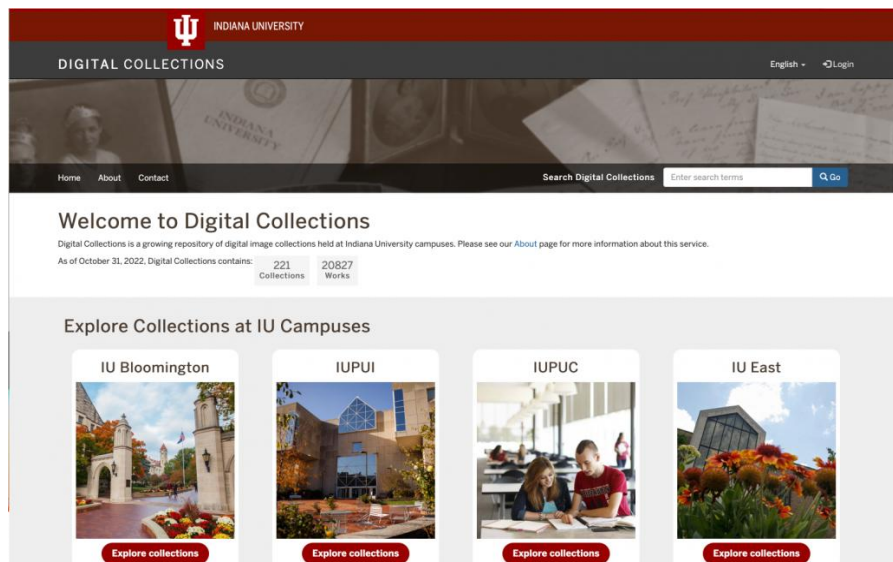
DSpace Digital Library Software Interface

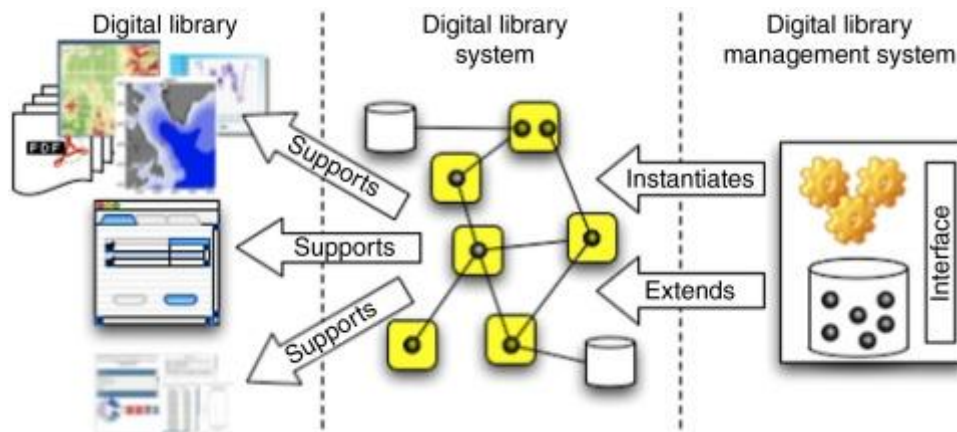
6. Review of Literature

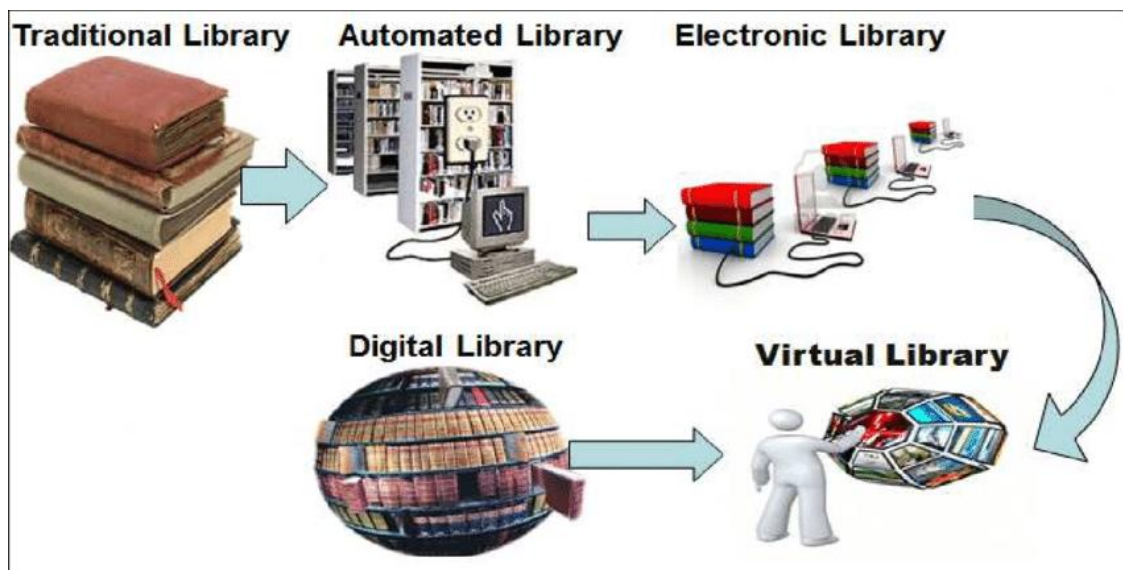

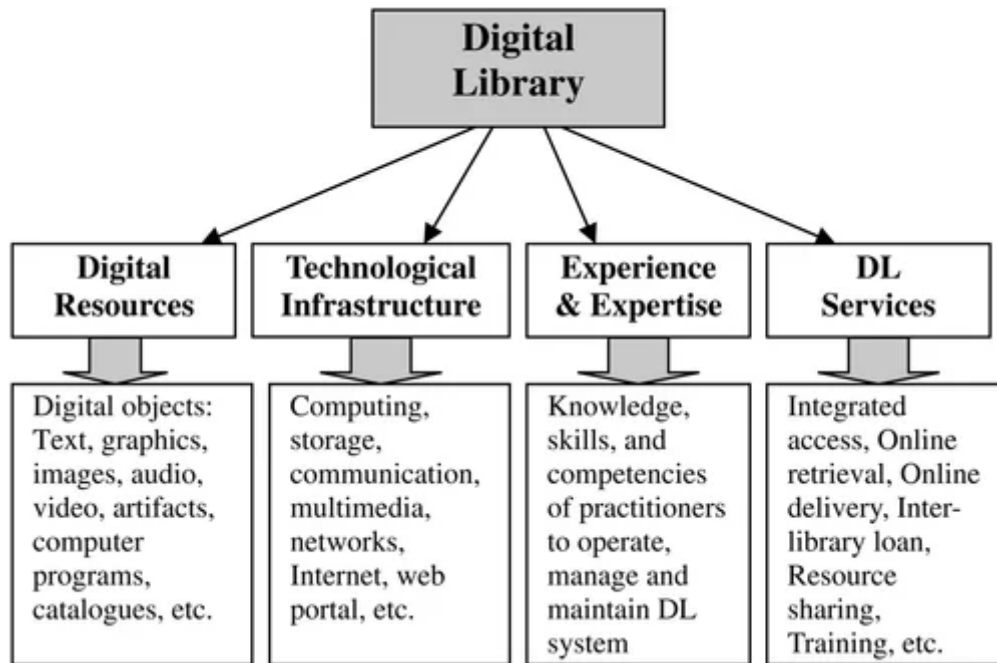

11. Major Findings

- Out of total respondents 58.29% are female.
- 31.11% respondents are studying at UG level, 50.77% respondents are studying at PG level, 10.07% respondents are research scholars and 8.05% respondents are from other categories.
- 68.53% replied that they visit the library once a week.
- 89.87% replied that they are highly aware of the digital library system.
- 83.91% replied that they are regularly using digital library platforms.
- 82.36% replied that the digital library platform is very much important for their study purpose.
- 55.90% replied that they use their mobile phone to access the digital library.
- 15.02% replied that they found few difficulties while accessing the digital library.
- From the study it was found that very few academic institutions have their own digital library system.
- Most of the academic institutions conduct orientation programs on digital libraries as well as e-resources platforms and also provide training on how to access these facilities.
- All the academic institutions under study have internet facilities in their libraries.

12. Discussions

From the study, it is found that most library users are aware of the digital library. They are frequently using many digital library platforms. Most of the respondents replied that they always use the National Digital Library of India (NDLI). Also, they use many open access platforms to access the e-resources. Few academic institutions have a digital library platform. Library users use these platforms too. A few respondents replied that they are less aware of the digital library platform. As they mostly prefer to visit physically in the library and are also in favor of reading printed materials.
